A nurse practitioner must be licensed or otherwise recognized as a nurse practitioner in a State, possess a master's degree from a program accredited by the NLNAC or CCNE, and maintain full and current certification as a nurse practitioner from the American Nurses Association or another nationally recognized certifying body.

APRNs are clinicians with advanced degrees and training who provide primary, acute and specialty health care services; they complete masters, post-masters or doctoral degrees. Certified Registered Nurse Anesthetists administer anesthetics for all types of surgery and various other procedures. They are advanced practice nurses prepared at masters or doctoral level and then certified by the National Board of Certification and Recertification for Nurse Anesthetists (NBCRNA) after having passed the examination.
